WE HOSTED A NATIONAL CONFERENCE IN JUNE 2019 IN PHILADELPHIA WHERE OVER 105 PEOPLE ATTENDED COMPRISED OF PATIENTS, CAREGIVERS, FACULTY, PHARMA EXECS, AND STAFF. SIXTY PERCENT OF THOSE AFFECTED WITH GORLIN SYNDROME HAD NEVER ATTENDED A NATIONAL CONFERENCE BEFORE. THE UNIFYING BOND WAS THE SAME FOR EVERYONE - SUPPORT, EDUCATION, AND CONNECTION. EXPERTS IN GORLIN SYNDROME PROVIDED LECTURES AND ANSWERED QUESTIONS FROM PATIENTS, AND FAMILIES INTERACTED WITH EACH OTHER, HELPING TO ALLEVIATE THE FEELING OF BEING ALONE WITH A RARE DISEASE.
